# **Background**

The first session provides insights and practical guidance on the Superintendent Officer's role as a contract administrator in two main aspects during the contract implementation stage of a construction project. The SO's supervision and certification duties are defined by the provisions in the PWD 203, both as the employer's agent and contract administrator. The latter role imposes on the SO an obligation, not only to make professional judgement, but also a duty to act fairly between the contracting parties.

The second session focuses on how CIPAA 2012 affects the industry players. It is important that the contracting parties should be aware of their payment obligations under the contracts. They may be subjected to statutory adjudication if they fail to make timely payment for completed work. The right for adjudication is provided under the Act which, among other things, prohibits conditional payment and provides remedies for the payment recovery.

### **Objectives**
